# SECURE PARKING? WITH ROSI'S AND ESPORG, THAT'S A SAFE BET.

*Anyone who transports freight also wants it to arrive safely and fully at the customer's site. Especially in the just-in-time era, entire industries depend on a reliable supply chain. With secure parking for heavy goods vehicles, ROSI'S service stations guarantee the safe and reliable arrival of your deliveries.*

At its Leipzig plant, Porsche is producing two series of sports cars with 35 to 40 engine variants alone, tailored to individual equipment requirements. Every year, the plant moves more than 200 million parts using 5.6 million carriers. The site receives goods from around 700 suppliers, an increasing number of which are based at distant locations. This poses risks for just-in-time delivery by heavy goods vehicles that are rolling warehouses, especially when they not only arrive late, but don't reach their destination at all. Secure parking areas for heavy goods vehicles, where drivers can take their legally prescribed rest periods, are an effective solution against cargo theft and thus protect the supply chain – not only for the automotive industry.

Under the brand ROSI'S Autohöfe, Tank & Rast currently offers more than 280 level 2 and 4 ESPORG Standard-certified secure parking spaces at Zeven-Elsdorf (A1 exit 48), Rheda-Wiedenbrück (A2 exit 22), Nahetal (A61 exit 50) and Wörnitz (A7 exit 109), with more being constantly added. Just recently, ROSI'S Autohof Pilsting (A92, exit 19) became the latest addition, offering fifty secure parking spaces for heavy goods vehicles, 20 of which correspond to level 4 and 30 to level 2. The year 2020 is also set to be characterised by the further expansion of ROSI'S motorway service station locations and the number of certified secure parking spaces.

The safety levels correspond to the specifications of the European Secure Parking Organisation (ESPO) and therefore represent the highest level of security and service in the parking sector.

Building on this, the certification of existing secure parking in accordance with the new EU standards is also planned for 2020, thus enabling ROSI'S service stations to promptly meet these new requirements, too.

Safety level 2 parking is equipped with a fence, entrance and exit barriers and camera surveillance. Level 4 offers even more safety for heavy goods vehicles. Parking areas in this category have higher fencing than those in level 2 as well as a roller shutter and video surveillance across the entire parking zone. When entering, the vehicle registration is recorded on camera and printed on the parking ticket. The licence plate images are then compared by station staff upon exit and the barrier only opens if they match.

However, safety is not the only focus at service stations in the Tank & Rast network. ROSI'S service stations are also characterised by their extensive offer and special service approach, which is particularly appreciated by HGV drivers on long-distance journeys through Germany. With table service in the restaurant, ROSI'S consciously focuses on a friendly welcome and personal contact to give those travelling an opportunity to relax and a break from their HGV or car journey. In the ROSI'S restaurant, guests can enjoy a varied selection of grilled dishes, burgers and fresh salads. As well as modern toilet facilities, the service stations provide convenient showers, washing machines and tumble dryers, thus offering a comprehensive safety and service portfolio that makes stopping a pleasure for all HGV drivers.


