

#### EXCELLENCE IN TRUCK PARKING AWARD APPLY NOW TO BECOME THE BEST EUROPEAN TRUCK PARKING IN 2023



## Safe and secure truck parking areas across Europe are invited to submit their dossiers for the 2023 edition of ESPORG's Excellence in Truck Parking Award by 10 February 2023.

ESPORG, the European Secure Truck Parking Organisation, is now welcoming candidate applications for its 2023 Excellence in Truck Parking Award edition, with the objective to promote safety, security, quality, connectivity and care in providing services to professional truck drivers when using safe and secure truck parking areas.

The aim of the European Truck Parking Award is to promote excellence and to help spread good practices in view of improving safety, security and quality of services offered by truck parking operators to professional truck drivers, and, by doing so, to enhance the attractiveness and appeal of the driver profession to an increasingly diverse and wider public, including young people and women.

As a reminder, in 2022 the French Truck Etape Béziers parking facility was voted European Truck Parking of the Year. In particular, the jury commended the completeness and excellence of the winner's service offer to drivers and attention to the smallest details, including environment, health, recreation, affordability, and indeed individual care to every single driver.

Candidates can be small (up to 50 spaces) and large (more than 50 spaces) public and private truck parking areas, as well as road transport companies operating truck parking facilities, which have been audited and already satisfy one of the four levels of the EU-Parking Standard – Bronze, Silver, Gold, Platinum. They must prepare a dossier in the English language and submit it by 10 February 2023. The winners and runners up will be unveiled at a public ceremony, to be held on 1 March 2023.

"The ESPORG Award supports the EU standards for safe and secure truck parking areas, whilst at the same time promoting the best among them. We invite truck parking areas from all over Europe to apply by 10 February 2023, to compete for this prestigious award.", said Dirk Penasse, ESPORG's General Manager.

## CALSINA CARRÉ SERVICES: CARRIER AT CARRIER'S SERVICE



Currently, in the European context of a lack of infrastructure for transporters to be able to carry out their profession with dignity and ensure compliance with regulations, there is a need for commitment by the organizations that constitute the sector to improve drivers' working conditions. This is the reason why the transport and logistics company, Calsina Ca-rré, decided to open its facilities to external drivers. In doing so, Calsina Carré aims to impro-ve the quality of professional drivers' breaks with a wide range of services in a safe and pro-tected environment. Who could do better than Calsina Carré, which is already a fleet opera-tor and very knowledgeable about the sector needs?

Calsina Carré Services is a translogistic hub strategically located in the Mediterranean Corri-dor, 18 kilometres from the French border. Its location is also next to Vilamalla, future in-termodal and logistical zone of the province.

To take this step, Calsina Carré, who already boast very powerful facilities at the Pont de Molins headquarters, has chosen to invest extra in order to guarantee the highest service quali-ty. The company has put forth major effort to



expand areas in order to provide 100k m2 equipped with different services and facilities specially intended for drivers and their vehi-cles. Calsina Carré Services has currently 400 parking spaces available, however, the compa-ny is planning a second phase of the project for the end of 2023, which foresees an expan-sion of the parking area along with new service modules.

The gas station, which had 4 lanes, has been remodeled by doubling the number of lanes to ensure easy access and avoid queues. The station stocks diesel, diesel A, AdBlue and gasoline and has its own staff to provide assistance if needed.

The area enabled for external carriers is equipped by modules with everything the driver may need during the resting period of his trip: restrooms, showers, laundry service, luggage storage room, vending machines, wifi and rest area.

Calsina Carré Services was born with a clear focus on security and quality. All facilities are equipped with 24h video surveillance cameras, controlled access barriers and a whole inte-grated IT system based on QR codes. All these improvements catapulted the company for-ward to obtain one of the highest quality certifications for the European safe and secure truck parking areas: the Gold level of the EU-Parking Standard.

The services devised for the vehicle are also included in these facilities, which feature a washing tunnel, the possibility of tire assistance and punctual repairs, along with the sale of safety elements and replacement spare parts.

In addition, the company is able to offer all the logistical support as a carrier with 50 years of experience: the possibility of storage, movement of goods and even transport collaborations.

Calsina Carré Services is a major investment in the future of the company, which intends to continue growing and searching for opportunities to improve the sector by providing value, proficiency and service.



## TRUCK PARK BRESCIA EST RECEIVES "GOLD" LEVEL SSTPA CERTIFICATION

A further confirmation of the high standards of safety and services offered by the largest truck park in Europe





Truck Park Brescia Est has obtained the GOLD level "Safe and Secure Truck Parking Areas -SSTPA" certification.

The SSTPA certification is issued by DEKRA, the only accredited body in Europe, and it is based on the EU-Parking Standard defined in the legislation of the European Commission and supported by ESPORG for truck parking areas. This certification is awarded to those areas that guarantee high safety for drivers, heavy vehicles and goods that significantly contribute to the modernization of road transport in Europe. Truck Park Brescia Est is an integral part of the services that A4 Holding, an Abertis Group company, offers to truckers. Born in 2009, this area presents a new concept of structure mainly dedicated to heavy vehicles where customers can stay or spend the night leaving vehicles in total safety and comfort and find all the services dedicated to their trucks.

The structure is located at the "Brescia Est" exit of the A4 –Torino-Trieste motorway in the north of Italy. Open 24/7, over the years it has become an increasingly important reference point for every truck driver who uses the A4 motorway, which crosses Italy from east to west, thanks to its central position. It is considered a true "transport citadel" where everything is organized and studied in detail to guarantee efficiency and speed in the service.

There are three key words for travellers that stop at Truck Park: safety, convenience and relax. What makes this area so special is the capacity to answer to the specific and unique truck drivers needs, having dedicated services that make Truck Park different from other structures, which can be simple service or rest areas. This certification confirms the high-level standards of safety and services offered at Truck Park, which hosts more than 150 thousand heavy vehicles parked in its approximately 400 parks every year, data that make the Brescia Est area the largest truck park in Europe.









In addition to the wide range of services guaranteed to transporters such as the Santa Giulia Hotel, the filling station, the market, the truck washing and a spare truck parts shop, the safety system for the parking of trucks has recently been renewed, and now provides closed circuit cameras and an active surveillance within a fenced area, forming an exceptional safety system. These requirements have allowed Truck Park to obtain the "GOLD" level of SSTPA certification, being the first and only in Italy, confirming on one hand the high quality of the services offered, and on the other hand the safety guaranteed to drivers and the goods transported.

"Having obtained this certification – says director Pier Giovanni Pisani - represents a great achievement for our Truck Park, which consistently looks to the future, always ready to renew itself and find new solutions to be in step with the times and respond to new and different needs. As a matter of fact, the structure will soon be implemented with alternative fuels systems and a specific service of parking for expensive goods."

## SAFE AND SECURE TRUCK PARKING AREAS: ESPORG ASSOCIATED MEMBER NOMADPOWER OFFERS SER-VICES TO COMPLY WITH EU REGULATIONS

Road transport is an important part of European supply chains with Heavy Goods Vehicles (HGVs) transporting goods worth billions of euros every day. The economy of Europe relies on these transportation systems to maintain consistent supply of goods and services. Despite be a lack of quality standards when it comes to working conditions for drivers and security level of truck parks. These problems lead to a decrease in job attractiveness, and thus, demand for recruitment, which is a negative influence on the industry. To solve these issues, The European Union has attempted to improve the quality of European truck parks. The European Commission (EC) introduced the EU-Parking Standard for Safe and Secure Truck Parking Areas (SSTPAs) in 2018, including points regarding both security and service. In April 2022, they proposed even more measures to get closer to their goal. It seems like truck parks will need to tick a lot of boxes to be considered safe and secure, as well as to obtain funding.

#### What are the new measures?

The EC has introduced new measures that truck parks need to comply with in order to obtain necessary assessments and certifications. These are in alignment with the Mobility Package, which are the newly approved rules aiming to enhance the working conditions of drivers, avoid illegal activities in road transport, procure fair competition, and ensure equal pay. The EC intends to lay a strong foundation of minimum standards for truck parks and coordinate consistent and satisfactory operations all over Europe. This interconnected framework will also involve compatible information communication and technology (ICT) solutions to modernize the systems. Here are the five main measures that the EC will require from truck parks:

- **1.** Food and beverage options: In addition to snacks and drinks that are available 24/7, dining areas will be required as well.
- 2. Gender-friendly sanitary facilities: These include gender-specific toilets and showers, along with hot water taps and hand soap. Daily cleaning and inspection are also mandatory for these facilities.
- **3.** Communication connections: Internet should be free to use for drivers.
- 4. Availability of emergency contact points and procedures: Precautions should be taken to assure safe traffic movement. Plus, the emergency contacts should be provided at least in English, also demonstrated with easily understandable graphics.
- 5. Power supply: Power outlets should be accessible for personal use. Moreover, there should be electric charging stations compatible with refrigerated vehicles by December 31, 2026.

Furthermore, four security levels (Platinum, Gold, Silver, and Bronze) are introduced as well, which will be dependent on factors such as entry & exit procedures, security guards, and CCTV cameras. These will help clarify how secure both new and existing parking areas are.



"The EU-Parking Standard provides measures for truck parking areas which give a minimum requirement of service and security measures for drivers. The idea is to have safety, security, quality, connectivity and care in providing services to professional truck drivers when using safe and secure truck parking areas. It is why we push our members to certify their truck parking areas according to the EU-Parking Standard and have used it as basis criteria for our ESPORG Excellence in Truck Parking Award," says Dirk Penasse, General Manager of the European Secure Parking Organisation (ESPORG), which was one of the driving forces behind the study that created the EU-Parking Standard.

#### What can you do about it now?

It is important to fulfill these requirements as early as possible. While the first four of them are relatively easier to complete, the fifth one, i.e. electric charging infrastructure for refrigerated vehicles, is the one that will make a difference. Refrigerated vehicles are a core element of the supply chain, as they are responsible for delivering frozen and refrigerated products in compliance with health and safety rules on a daily basis. Due to their crucial importance and the current lack of available parking places for them, the EC decided to prioritize their operations and expect all the safe and secure truck parks to offer electric cooling stations for these vehicles.

What you can do now is find out what type of refrigerated vehicle charging infrastructure would be the best option for your truck park, and start planning their installation. This is an important step to not only earn the title of a "safe and secure truck park" by the EU, but also to attract more drivers to your location. 2026 might seem like a far date, but early birds are always rewarded.

#### How can NomadPower help you?

In addition to finding the ideal pedestal for your park, they will guide you on how to install and show you how to best administer your system. ### CEF SPOTLIGHT: MALEX THOR

ESPORG Member Malex Thor is building a CEF-funded parking area which will be one of the first safe and secure parking areas in Europe at Platinum level.

The main objective of this project is to build a new and secure parking area and contribute to the development of a dense network of SSTPAs located on European freight corridors.

The safe and secure parking area will provide 86 safe and secure truck parking spaces and two electric charging stations for trucks as well as a building with services for truck drivers, such as toilets, showers for men and women.

The larger project encompasses a gas station platform and building (fast fuel and additives supply for trucks, restaurant and minimarket), a truck wash and a hotel (47 rooms + bathrooms).

The project will be located near the A1 motorway, less than 500 metres from the Seceani A1 exit, and about 1 kilometre from the Ortisoara exit, making it accessible from both sides of the A1 motorway. Two European TEN-T corridors overlap on this section of the A1: RHINE- DAN-UBE and ORIENT/EAST-MED.

The project is being implemented in a favourable context for investments in the transport sector. Both European and national policies are encouraging new investments in the transport sector, including safe and secure parking for trucks.

The realisation of the project will have a considerable social impact as it will respond to existing needs and problems in the field, such as:

- reducing the travel time needed to reach a secure parking area;
- improving working conditions for professional drivers of goods vehicles by providing high quality services;
- making trucks less vulnerable to theft by providing safe parking spaces;
- minimising the indirect externalities that can affect the population while searching for secure parking spaces such as air pollution, greenhouse gas emissions, etc.

We are looking forward to this exciting project materialising next year and to offering the first Platinum parking area in Eastern Europe.
